

Savings Plan Promotion / Terms & Conditions / February 2023

- 1. BUX B.V. ("BUX") is giving away EUR 2 023 (This Promotion) to a randomly selected user of the BUX Zero app ("BUX Zero app"), under the conditions specified below.
- 2. To enter This Promotion you need to set up a Savings Plan* before 07-02-2023 23:59.
- 3. To qualify for the Prize you need to:
 - a. Have a funded Investment Account in the BUX Zero app during February, March and April of 2023.
 - b. Have an active Savings Plan*, executed with a minimum amount of €150 per month in the BUX Zero app during February, March and April of 2023.
 - c. Only your first (one) active Savings Plan is eligible to receive a prize. Creating more than one savings plan will not increase your chances of winning.
- 4. If the above conditions are met, you are automatically eligible to win the following prize:
 - a. One (1) winner will receive a grand prize of €2023 transferred to their BUX Zero account in the country that their account is associated with.
